- Full grille with foam backing for System 2000™ speakers: Sx500¹
- Provides an appropriate appearance for installations
- Intended for indoor use
- Simple installation using common tools

1. At the time of publication, the only System 2000™ model on which to use the G500 full grille accessory kit is the Sx500. Additional models are planned, and the general concepts and instructions given here should remain applicable for later models.

Description

The Electro-Voice G500 Full Grille Accessory Kit consists of an 18-gauge, cold-rolled-steel grille with foam backing and 10-16 x 3/4 screws (23 needed plus extra) for attachment.

The Electro-Voice G500 is a full-face grille for adding to the front of System 2000™ systems and is intended for indoor use. The grille allows the speaker to be less conspicuous in installations.

Equipment Required for Installation

power screwdriver (#2 Phillips head)

Installation Instructions

The G500 is easily installed onto the front of the Sx500 system using the supplied screws with a power screwdriver.

The first step is to place the speaker system on its back at a comfortable working height. Next, place the grille on the front of the speaker with the foam layer between the metal and the enclosure. Be sure that the grille is centered on the speaker system, both top-to-bottom and side-to-side.

The third and last step is to install the screws through the grille to the enclosure in the holes

provided in the metal grille. (Please see Figure 1.) The only screws which do not have specific holes in the grille are the three placed between the high-frequency and low-frequency drivers. The dimension on Figure 2 indicates where these screws should be placed.

A recommended order in which to install the screws is provided in Figure 2. This is only a recommendation and other methods may work equally well.

After the first screw is installed, be sure that the grille is still centered on the speaker. Then proceed with the remaining screws. To be sure ripples are not formed in the grille, be sure that the grille is flat before installing each new screw.

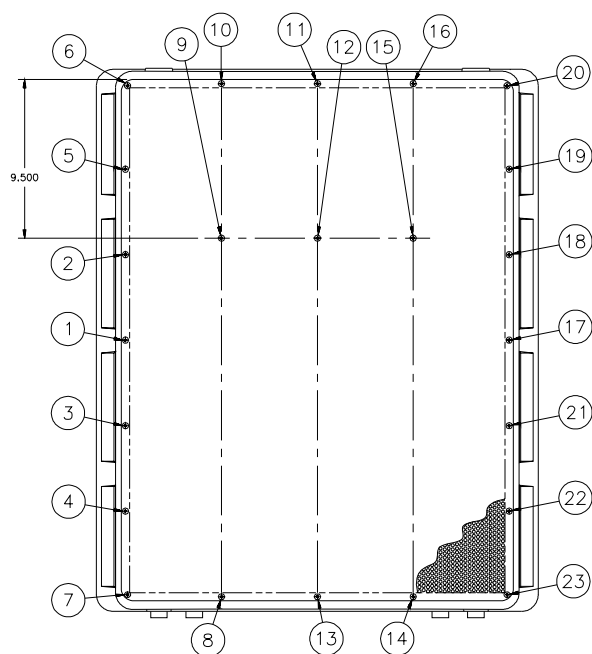
