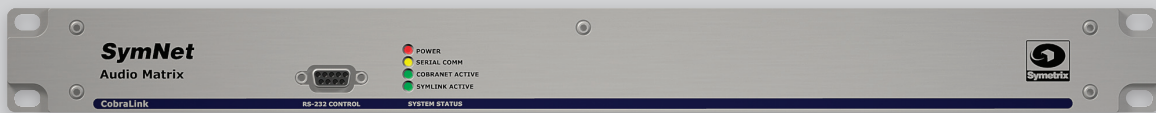

Before You Begin

What Ships in the Box

- ✓ A CobraLink hardware device.
- ✓ SymNet Designer CD-ROM (Windows)
- ✓ A SymLink patch cable.
- ✓ A ferrite clamp
- ✓ One PS-4 switching power supply which provides 6 volts DC @ 3.3 amperes. NOTE: The PS-4 will accept a 100-240V AC input. A power cable for domestic use is supplied for the PS-4. Export customers should supply the appropriate substitute cable for their locale.
- ✓ This Quick Start Guide.

What You Need to Provide

 - WIN 98SE or WIN 2000.
 - 10-15MB free storage space.
 - 1024x768 graphics capability
 - 16 bit or higher colors

 - 64MB RAM (WIN 98SE), 128MB RAM (WIN 2000).
- ✓ An available serial port capable of operating at 57.6 or 115.2 kilobaud.
- ✓ A cable to connect the RS-232 serial port of your PC to SymNet's front panel RS-232 input. The SymNet RS-232 input is a female DB-9 connector.
- ✓ Shielded CAT-5 cables as necessary

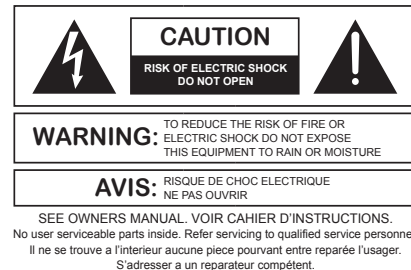

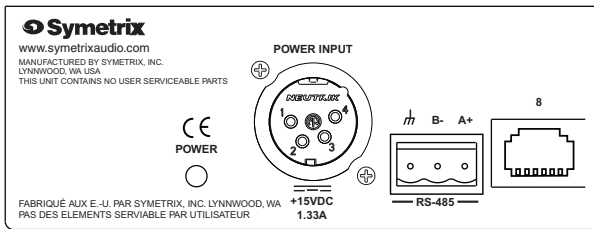
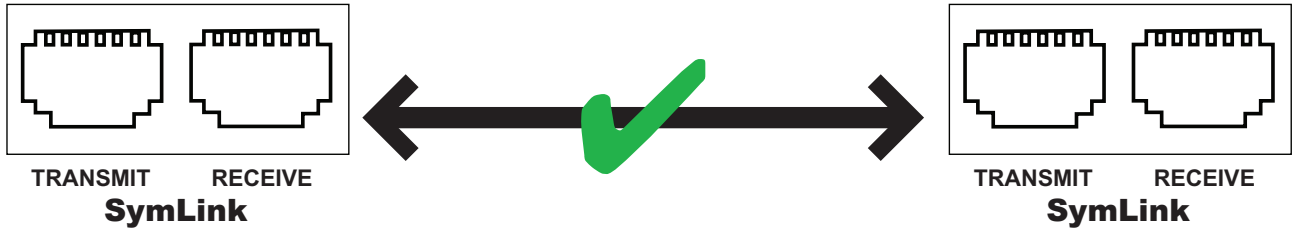
Power Source. SymNet CobraLink hardware uses a switching power supply that automatically adjusts to the applied voltage. Ensure that your AC mains voltage is somewhere between 100-240 VAC, 50-60 Hz. Use only the power cord and connector specified for the product and your operating locale. A protective ground connection, by way of the grounding conductor in the power cord, is essential for safe operation. The appliance inlet and coupler shall remain readily operable once the apparatus has been installed.

User Serviceable Parts. There are no user serviceable parts inside the SymNet CobraLink. In case of failure, customers inside the U.S. should refer all servicing to the Symetrix factory. Customers outside the U.S. should refer all servicing to an authorized Symetrix distributor. Distributor contact information is available online at: www.symnetradio.com.

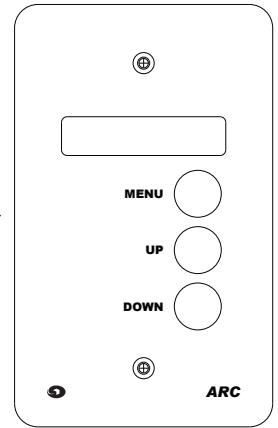


WARNING!

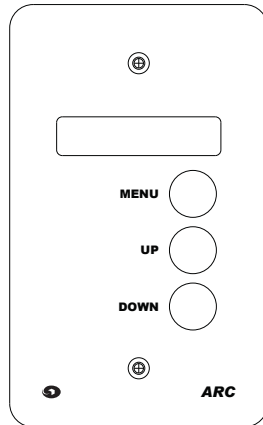
NEVER connect the RJ-45 connector (CAT-5) on an ARC, ARC-PS or Control I/O to any SymNet audio device's SymLink connector (also an RJ-45 connector). The RJ-45 connectors on SymNet products labeled as "SymLink" (Transmit or Receive) should only be connected to other RJ-45 connectors labeled as "SymLink" (Transmit or Receive). The RJ-45 connectors on the ARC, ARC-PS and Control I/O can carry anywhere from 6 to 15 VDC which can damage SymLink circuitry.



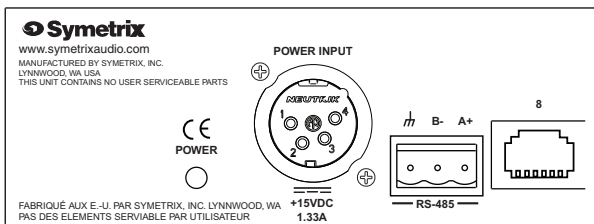
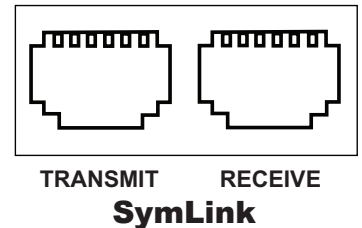
ARC-PS or Control I/O



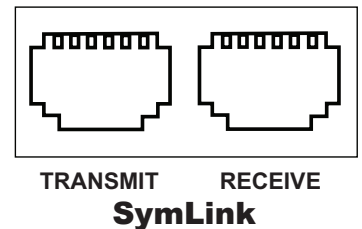

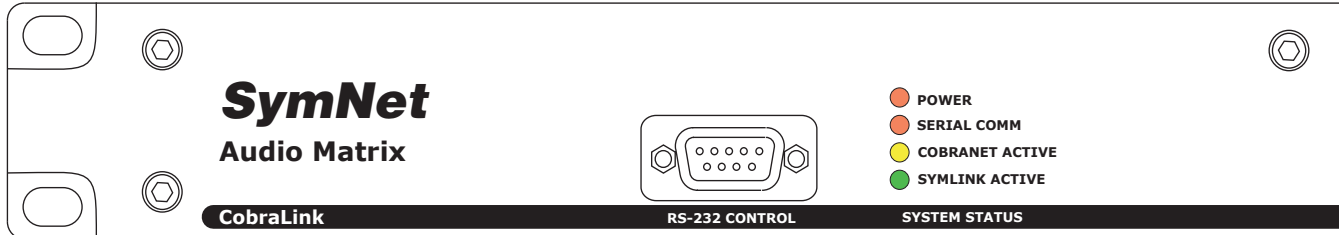

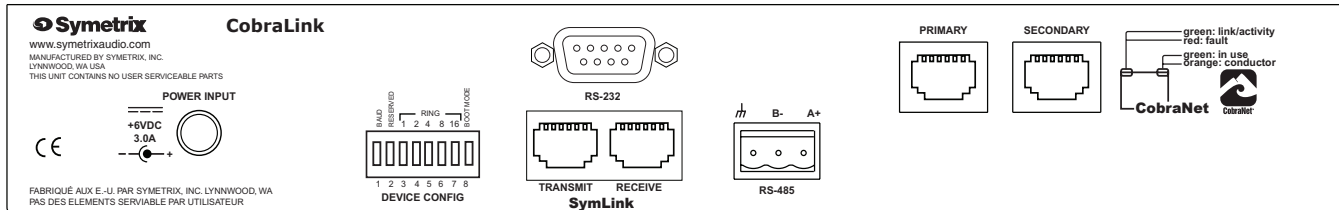

Hardware Connections And Switch Settings

Connection	Description	What It Does
RS-232 Control	DB-9 (d-sub) Female	Default serial communications interface for SymNet Designer on the host PC. Wired straight-through, only pins 2, 3 and 5 are required. <u>Port Settings:</u> 115 or 57.6 kbaud, 8 data bits, 1 stop bit, no parity, no flow control. Baud rate determined by DIP switch #1 which must match SymNet Designer's communications preferences.



Connection	Description	What It Does
POWER INPUT	2.0 mm Jack	Accepts power from Symetrix PS-4 (or equivalent) power supply only.
Device config	8 position DIP switch	1 (BAUD) - Sets front panel RS-232 baud rate. Default = UP = 115,200, DOWN = 57,600. 2 (not used) 3-7 (RING) - Sets ring number of the SymNet ring. In a system with more than one CobraLink unit, each unit must be given a unique ring number. Exactly one unit must be assigned to ring number 1, that is switch 3=DOWN, switches 4-7= UP. 8 (BOOT MODE) - Default = UP. Set to DOWN only if instructed to do so by a Symetrix Customer Support.
SymLink	RJ-45	Low-latency 64-channel audio and data bus. TRANSMIT connects to the next downstream SymLink device's receive port. RECEIVE connects to the previous SymLink device's transmit port. This forms the "SymLink Ring". Use shielded CAT-5 cables less than 10 meters in length, standard straight-through wiring.
RS-232	DB-9 (d-sub) Female	Default serial communications interface for a 3rd party accessory controller. Wired straight-through, only pins 2, 3 and 5 are required. <u>Port Settings:</u> 38.4 kbaud (default), 8 data bits, 1 stop bit, no parity, no flow control.
RS-485	Detachable Euroblock	Connects to a Control I/O, ARC-PS, ARC or other Symetrix SymNet family RS-485 controller, wired in parallel (A to A, B to B and GND to GND) using shielded twisted pair. <u>Port Settings:</u> 38.4 kbaud (default), 8 data bits, 1 stop bit, no parity, no flow control.
CobraNet	RJ-45	Connects the SymNet ring to a CobraNet network. Use the connector labelled PRIMARY The connector labelled SECONDARY is redundant and can be used if the CobraNet device you are connecting to has a SECONDARY port.

NOTE Included in the CobraLink packaging is a ferrite clamp. In order to maintain CE compliance, this clamp should be installed on the TRANSMIT side of each SymLink cable.

Common Problems and Solutions

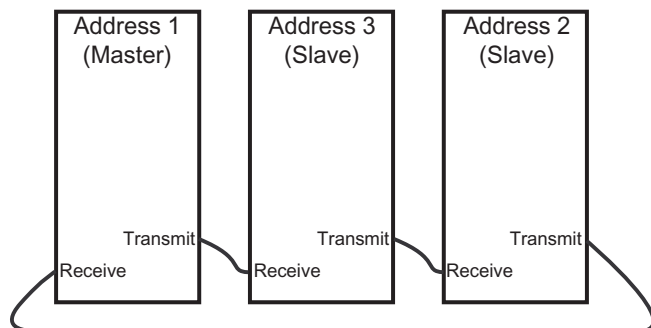

Dancing Lights. If any of your SymNet units power on and seem to suffer from Dancing Lights Syndrome, never fear. This simply means that there is no active configuration loaded. When designing your site, it is necessary to designate a particular configuration to be loaded at power on. This is done by opening your Site File in SymNet Designer and choosing “Triggers and Power On Default...” from the “Hardware” menu. In the dialog box that opens, click the “Change Power On Default...” button. Now choose which configuration (1 through 8 or None) you would like to be the power on default and click “OK”. You must now download your Site File to the hardware (F4) in order for the settings to be stored.

Serial Communications. Be sure that you use a *straight-through* RS-232 cable connected to the *front* DB-9 port labeled RS-232 CONTROL. You must connect to whichever unit is master for a given ring. It is permissible to connect to any ring provided that you connect to the master unit (the unit with an Address of 1). By default, SymNet Designer communicates with the hardware units at a baud rate of 115,200 bps. This is how the baud DIP switch (number 1) is configured in the examples on page 2. However, if you have a PC that is incapable of operating at this speed, a setting of 57,600 bps is available. DIP switch 1 will be opposite of the examples on page 2 and the speed of 57,600 bps must be selected in SymNet Designer’s Preferences dialog accessible from the File menu.

SymLink Communications. The SymLink bus uses industry standard CAT-5 shielded Ethernet cable. The SymNet units are interconnected in a Token Ring network fashion. The transmit of the first unit is connected to the receive of the second unit and so on. The last unit in the chain should then have its transmit connected to the first units receive to complete the ring. All SYMLINK ACTIVE green LEDs should be lit on the front of each SymNet device.

Firmware. IMPORTANT: Your hardware devices must be running the firmware that complements the version of SymNet Designer in use. If you are receiving this software with a new SymNet device from the factory, then the firmware versions should already be correct. However, if you are using it with an existing SymNet device, then the firmware must be upgraded. It is always wise to double check the versions on all units as a first step to troubleshooting communications errors.

SymNet Designer 1.2 and later features a “Verify” button in the Upgrade Firmware dialog. This makes it easier to verify that you have the correct Microprocessor firmware file for the currently running version of SymNet Designer. However, it does not check for the correct version of the FPGA firmware file. This must still be done manually.

Upgrading Firmware:

1. Install the latest version of SymNet Designer. The latest version is always available at www.symetrixaudio.com. The correct firmware version is included and installed with the SymNet Designer software.
2. Launch SymNet Designer.
3. Connect your hardware devices as they would be for normal operation. It is recommended you disconnect or power down all audio sources connected to SymNet during the upgrade.
4. In SymNet Designer, choose Hardware -> Upgrade Firmware. The dialog that appears will tell you the current version of the firmware in your hardware devices.
5. Click the Upgrade button under SymNet Microprocessor file. An open file dialog will appear allowing you to navigate for firmware files. By default it should take you into the C:\Program Files\Symetrix\SymNet Designer X.X\Upgrade folder. Select the most recent SNMvXXXX.bin file and click Open.
6. After this finishes, click the Upgrade button under SymNet FPGA file. Select the SDFvXXXX.bit file and click Open. (If you are upgrading a CobraLink device, select the CLFvXXXX.bit file instead.)
7. If you have more than one SymNet device, select each device using the address drop down at the top of the dialog box and repeat steps 5-6.
8. If you are using CobraLink and have more than one ring, also repeat for all devices on all rings using the Ring drop down at the top of the dialog box.
9. When finished, click Close.

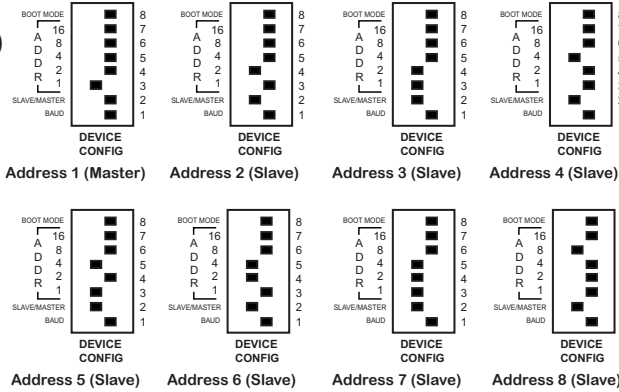
DIP Switch Reference

SymNet Family DIP Switch Settings

NOTE: As of SymNet Designer software version 2.0, a maximum of 32 Rings, each having 16 Addresses, are possible. For the sake of space, only switch settings for the first 8 Rings or Addresses are pictured.

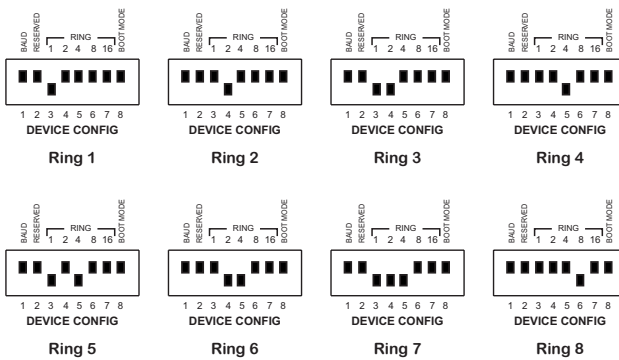
SymNet DSP (8x8, 8in and 8out)

NOTE: Only one Master is allowed on the Ring and it should be Address 1.



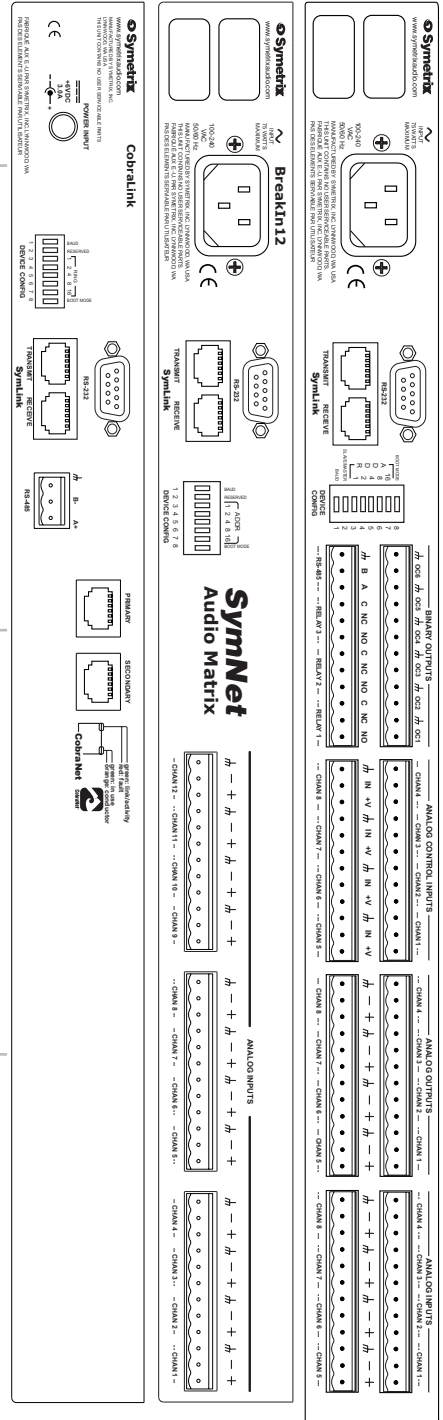
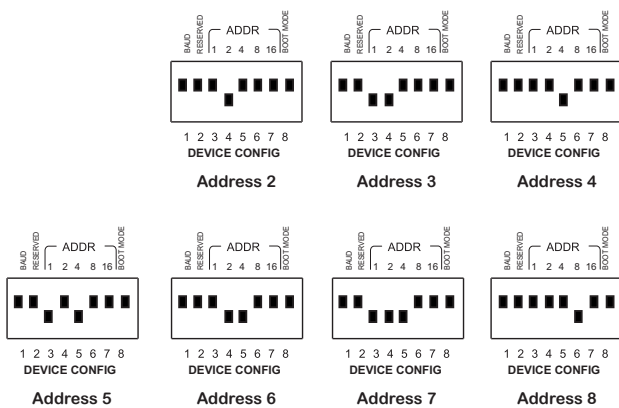
SymNet CobraLink

NOTE: The DIP switches on a CobraLink device configure its Ring number. A CobraLink device is always at Address 1 and is the Master of its ring.



SymNet BreakIn12 & BreakOut12

NOTE: An Address of 1 is not valid on the BreakIn12 or BreakOut12 since these devices can not be the Master on a Ring.



The Symetrix Limited Warranty

Servicing the CobraLink

If you have determined that your CobraLink requires repair services and you live outside of the United States please contact your local SymNet dealer or distributor for instructions on how to obtain service. If you reside in the U.S. then proceed as follows.

Return authorization

At the Symetrix factory, Symetrix will perform in-warranty or out-of-warranty service on any product it has manufactured for a period of three (3) years from date of discontinued manufacture.

Before sending anything to Symetrix, please contact our Customer Service Department for a return authorization (RA) number. The telephone number is (425) 778-7728. Additionally support is available via the web site: support.symetrixaudio.com.

In-warranty repairs

To get your CobraLink repaired under the terms of the warranty:

1. Call us for an RA number (have the serial number, shipping and contact information and description of the problem ready).
2. Pack the unit in its original packaging materials.
3. Include your name, address, daytime telephone number, and a brief statement of the problem.
4. Write the RA number on the **outside** of the box.
5. Ship the unit to Symetrix, freight prepaid. We do not accept freight collect shipments.

Just do these five things, and repairs made in-warranty will cost you only one way freight charges. We'll pay the return freight.

If you don't have the factory packaging materials, we recommend using an oversize box. Wrap the unit in a plastic bag, surround it with bubble-wrap, and place it in the box surrounded by Styrofoam peanuts. Be sure there is enough clearance in the box to protect the rack ears. We won't return the unit in anything but Symetrix packaging for which we will have to charge you. If the problem is due to operator misuse or error, you will have to pay for both parts and labor. In any event, if there are charges for the repair, you will pay for the return freight. All charges will be COD unless you have made other arrangements (prepaid, Visa or Mastercard).

Out-of-warranty repairs

If the warranty period has passed, you'll be billed for all necessary parts, labor, packaging materials, and freight charges. Please remember, you must call for an RA number before sending the unit to Symetrix.
