2. Return this completed form, including the serial number label, along with a copy of your invoice with the purchase price circled.  
**IMPORTANT: You must cut out and include the original label from the carton, which includes the UPC code, model number and serial number, or your registration cannot be processed.**
3. Offer valid for purchase made from December 1, 2016 – January 13, 2017. All registrations must be postmarked within 30 days of purchase.
4. This offer is only available to the end user and original purchaser. No registration from re-sellers, dealers/distributors, their employees or warehouse facilities, groups, clubs or organizations will be accepted or acknowledged.
