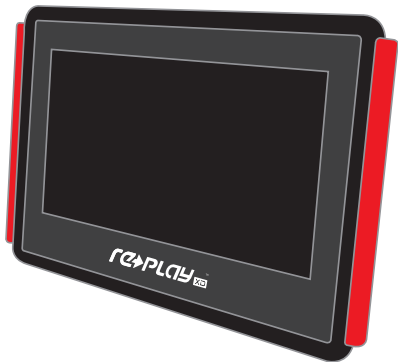


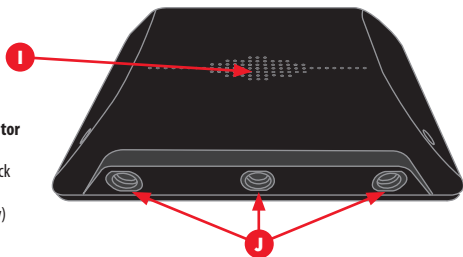
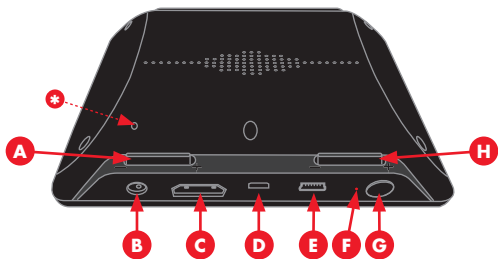

QUICK START GUIDE





### Replay XD ReView Field Monitor

- (A) Brightness Button
- (B) Audio Out 3.5 mm Stereo Jack
- (C) HDMI In
- (D) USB Mini 8-pin (Charge Only)
- (E) USB Mini (Charge Only)
- (F) Power On/Off LED
- (G) Power On/Off Button
- (H) Volume Button
- (I) Mono Speaker
- (J) 1/4-20 Tripod Mounts
- (\*) Master Reset

ORIENTATION



1. Plug the HDMI cable from your Replay XD1080 camera or other HDMI capable video camera into the HDMI port (C) of the ReView Field Monitor
2. Press the Power On/Off button (G) to power on.
3. Press the Brightness button [+ or -] (A) to adjust the LCD brightness
4. Press the Volume button [+ or -] (H) to adjust the audio output for the speaker or stereo jack.

PLAYBACK



1. Power on the ReView Field Monitor to check the battery status. A battery icon will appear at the right side of the screen. Please recharge if necessary.
2. To charge make sure the power is off
3. Plug a standard Mini USB cable into the ReView Field Monitor USB Mini port (E).  
(OPTIONAL if you have a Replay XD1080 USB cable, plug a Replay XD1080 Mini USB 8-pin cable into the ReView Field Monitor USB 8-pin port (D). YOU MUST ONLY USE ONE USB CABLE AT A TIME.)
4. Plug the opposite end into a Replay XD power adapter, car charger, or a PC/Mac USB 2.0 port.
5. The status LED (C) will illuminate red when charging, when the battery is full and charging is complete the red LED will turn off.

***Note: The Mini USB port is for charging only. Only use ONE USB cable at a time, either the Mini USB 8-pin or the Mini USB. DAMAGE MAY OCCUR IF YOU CHARGE WITH TWO USB CABLES PLUGGED IN AT THE SAME TIME.***
