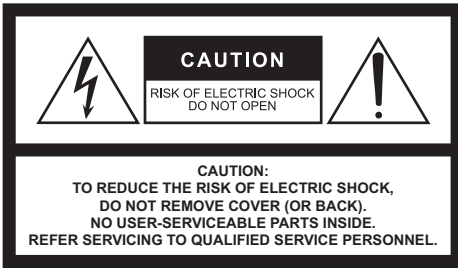

WARNING

If you notice any abnormality

- If any of the following problems occur, immediately disconnect the electric plug from the outlet.
 - The power cord or plug becomes frayed or damaged.
 - Unusual smells or smoke are emitted.
 - Some object, or water has been dropped into the product.
 - There is a sudden loss of sound during use of the product.
 - Cracks or other visible damage appear on the product.

Then have the product inspected or repaired by qualified Yamaha service personnel.

Power supply/power cord

- Do not place the power cord near heat sources such as heaters or radiators, and do not excessively bend or otherwise damage the cord, place heavy objects on it, or place it in a position where anyone could walk on, trip over, or roll anything over it.

- Only use the voltage specified as correct for the product. The required voltage is printed on the name plate of the product.

- Keep the device and small parts out of reach of children, to keep them from putting their fingers into openings on the product and accidentally being injured. There is a danger that children might swallow small parts. This product is not suitable for use in locations where children are likely to be present.
- Do not block the vents. This product has ventilation holes at the top/front/rear/sides to prevent the internal temperature from becoming too high. In particular, do not place the product on its side or upside down. Inadequate ventilation can result in overheating, possibly causing damage to the product(s), or even fire.

Handling and maintenance

- Do not touch any port with your fingers or anything metallic. Failure to observe this precaution could result in damage to the product.
- Do not expose the product to excessive dust or vibration, or extreme cold or heat (such as in direct sunlight, near a heater, or in a car during the day), in order to prevent the possibility of panel disfiguration, unstable operation, or damage to the internal components.
- Condensation can occur in the product due to rapid, drastic changes in ambient temperature—when the product is moved from one location to another, or air conditioning is turned on or off, for example. Using the product while condensation is present can cause damage. Saving data

- This unit has a built-in backup battery that maintains time information for the data. When the backup battery runs down, the time information will be initialized, causing incorrect time information to be recorded in the log. If this occurs, contact your dealer or a Yamaha customer service center to have the backup battery replaced. The life span of the backup battery is approximately 10 years, but this may vary depending on the conditions of use. Set the clock after replacing the battery.

 - Time information.

Introduction

Thank you for purchasing the Yamaha SWR2311P-10G intelligent L2 switch.

This product supplies power to PoE powered devices on the network.

This owner's manual is intended for installers and facility designers, and explains installation methods and settings.

Please be sure to read this manual before you start using the product to take full advantage of its features.

Please retain this manual in a safe location for future reference.

Features

- Recommended settings for stable operation of a Dante network (such as QoS, EEE, and IGMP Snooping) can be made easily.
- Up to 30W of power can be simultaneously supplied to each port that supports PoE power supply.
- A function is provided to automatically reset a device that is being powered from this unit by turning its power supply on/off if an abnormality is detected in that device.
- The PoE supply status can be checked or turned on/off via Yamaha LAN Monitor.

Separately sold items

- RK-SWR rack mount accessory: This is required when installing the unit in a 19-inch rack.
- WK-SWR wall mount accessory: This is required when installing the unit on a wall or on a ceiling less than 2 meters high.
- SFP-SWRG-LX or SFP-SWRG-SX SFP module: This is required when connecting via 1000BASE-LX or 1000BASE-SX.

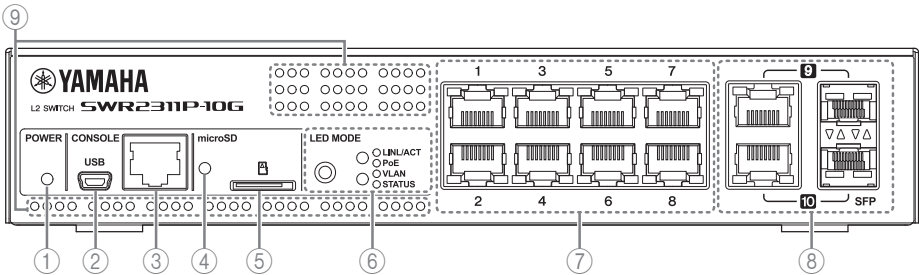

Controls and Connectors

Front Panel



① POWER indicator

Lights when power is provided to the unit.

POWER indicator	Status
Unlit	Power off
Flashing (green)	Power on, starting up
Lit (green)	Power on, normal
Lit (orange)	Power on, error occurred



Caution

When one of the following problems occurs, the POWER indicator is lit orange. Verify the status of the problem, and take the appropriate action. Refer to the Web GUI to determine which specific problem has occurred.

- Fan stopped
The fan that exhausts the heat dissipated by this unit has stopped.
You must immediately stop using the unit, and contact a Yamaha service center listed at the end of this manual to have the unit repaired or inspected.
- Abnormal temperature inside this unit.
The temperature inside this unit is abnormal.
Reconsider the environment in which this unit is installed, and correctly install this unit so that its internal temperature is appropriate.

② mini-USB CONSOLE port

This is a mini-USB port for making settings. Use a USB cable to connect it to the USB port of a computer. Use a USB cable equipped with a USB Type A connector and a mini-USB Type B (5-pin) connector.

Notice

Use a cable that supports data transfer. Charge-only cables cannot be used.

Controls and Connectors

③ RJ-45 CONSOLE port

This is an RJ-45 port for making settings. Use an RJ-45/DB-9 console cable to connect it to the RS-232C connector (COM port) of the computer. Use an RJ-45/DB-9 serial cable that is wired as described in “Appendix.”

④ microSD indicator

Indicates the connected and operating status of the microSD card.

microSD indicator	Status
Unlit	No microSD card is inserted in the slot.
Flashing (green)	The microSD card is being accessed.
Lit (green)	A microSD card is inserted in the slot.



Caution

Do not remove the microSD card if this indicator is flashing green.

Doing so will damage the data.

⑤ microSD slot

A microSD card can be inserted in this slot.

⑥ MODE button and MODE indicator

When you press the MODE button, the display mode of the port indicators is switched in the following sequence, allowing you to check the current status by the upper and lower MODE indicators.

- When the initial display mode is LINK/ACT
[LINK/ACT] ► [PoE] ► [VLAN] ► [STATUS] ► [OFF] ► back to [LINK/ACT].
- For details on the MODE button that switches modes and the MOD indicator, refer to “Switching the display mode” (page 16).
- For details on the port indicators in each selected mode, refer to “Port indicators” (page 17).

⑦ LAN ports

These ports can supply PoE and are compatible with 10BASE-T, 100BASE-TX, and 1000BASE-T.

PoE supply is compliant with IEEE 802.3at, and can supply up to 30W to all ports.

⑧ LAN/SFP combo ports

These can be used either as LAN ports or SFP ports.

LAN ports are 1000BASE-T uplink ports. They do not have power supply capability. SFP ports are for installing a separately sold SFP module (SFP-SWRG-LX or SFP-SWRG-SX).

For details on installing an SFP module, refer to “Installing an SFP module” (page 28) in “Connections.”



Caution

Do not connect a cable to both the LAN port and the SFP port of the same port number.

Doing so might cause a malfunction.

⑨ Cooling vents

External air is taken in through these cooling vents.

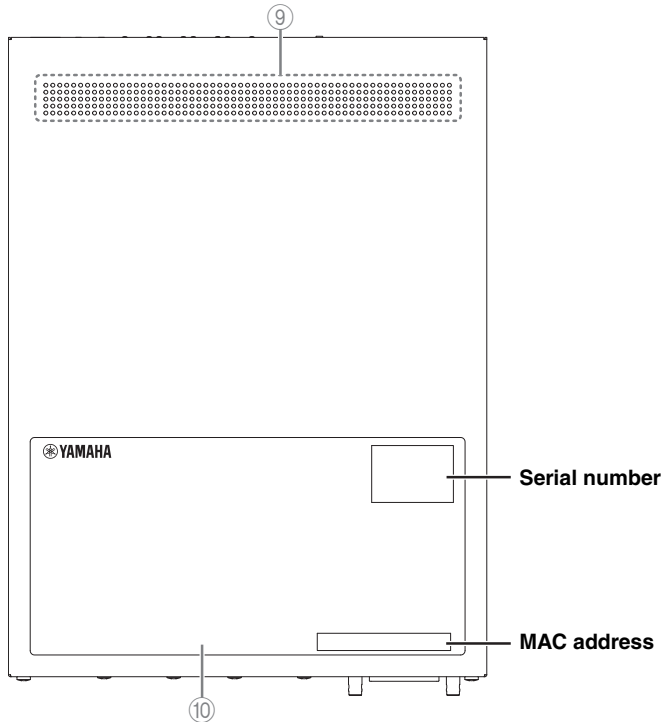

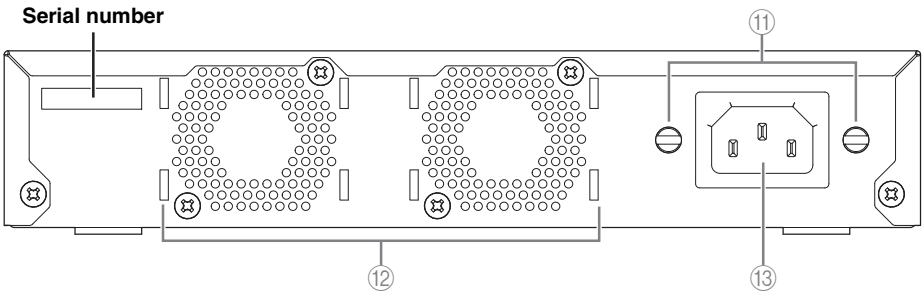

11 Power cord clamp attachment holes

The included power cord clamp (C-shaped) can be attached here. Refer to “Connecting the power cord” (page 30) for information on how to install the unit.

12 Fans

These forcibly exhaust the heat that is generated inside the unit. When a problem is detected, the POWER indicator is lit orange.



Caution

Do not block the fan vents or place objects near them. Doing so could cause fire or malfunctions.

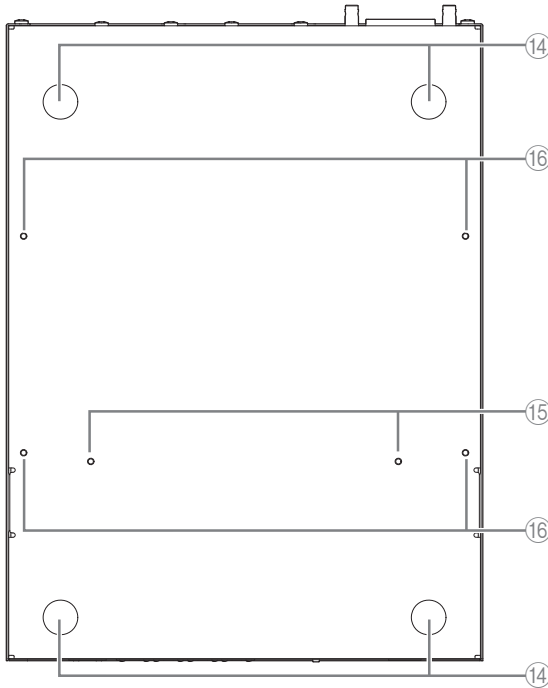
13 Power supply inlet (three-pin connector, C14 type)

Insert the included power supply cord here. Connect it to an electrical outlet of the appropriate voltage for the unit.

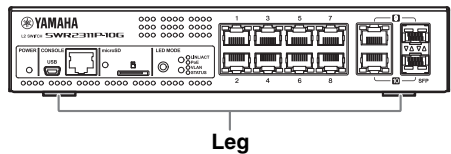
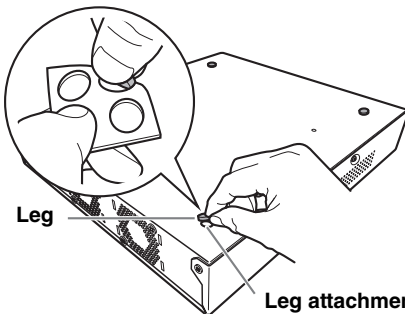

Switching the display mode

Each time you press the MODE button, the display mode of the port indicators is switched. The lit status and color of the upper and lower MODE indicators shows the selected display mode.

Unlit:  Lit (green):  Lit (orange): 

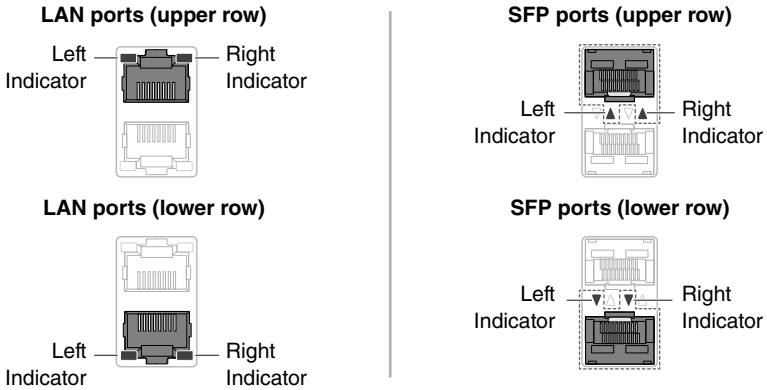

Mode name	Lit state of the mode indicators	Explanation
1 LINK/ACT	 <p>Upper Lit (green) Lower Unlit</p>	The left indicator of the LAN port or SFP port shows the link status, and the right indicator shows the connection speed.
2 PoE	 <p>Upper Lit (orange) Lower Unlit</p>	Indicates the power supply status of the LAN port.
3 VLAN	 <p>Upper Unlit Lower Lit (green)</p>	Indicates the VLAN ID specified for the LAN port or SFP port.
4 STATUS	 <p>Upper Unlit Lower Lit (orange)</p>	Indicates the error status of the LAN port or SFP port.
5 OFF	 <p>Upper Unlit Lower Unlit</p>	Turns off the indicators of the LAN ports and SFP ports.

1 Back to LINK/ACT

Port indicators

These are indicators for the LAN ports and SFP ports, and indicate the state of each port in each mode.



■ LINK/ACT mode

The indicators show the link status and connection speed of the LAN port or SFP port.

Installation in a rack

This section explains how to attach an optional RK-SWR rack mount accessory to the unit.

Please read before mounting the unit into a rack

This unit is warranted to operate in an ambient temperature range of 0–40 °C. If you install this unit along with other devices into an EIA-standard or JIS-standard rack, the temperature inside the rack may rise due to heat released from the other devices, resulting in poor performance of the unit. To prevent the temperature inside the unit from rising, mount the unit in the rack in accordance with the requirements below.

- If you plan to rack-mount the unit along with a device that tends to generate heat, such as an amplifier (excluding an XMV series), be sure to leave a gap of 1U or more from such devices. Also, be sure to maintain sufficient ventilation in this space by installing a ventilation panel or leaving it open.
- Open the rear panel of the rack, place the rack 10cm (about four inches) away from the walls and ceiling to keep sufficient ventilation. If you cannot open the rear panel of the rack, install a commercially-available forced ventilation device, such as a fan kit. If you install a fan kit, closing the rear panel may work better for heat dissipation purposes. For more information, refer to the owner's manual for the rack and/or fan kit.



Caution

If you plan to relocate the rack, be sure to first remove this unit from the rack.

If you move the unit while it is still installed in the rack, vibration or physical shock might deform or damage the rack mount accessory, causing injury. This might also cause the unit to malfunction.

[Installation]
