



#### MOUNTING DUAL CABLE DUCT BETWEEN 2 OR 4 POST RACKS


Using supplied hardware, install Brackets as shown (four places). See **FIGURE B** for appropriate orientation.

NOTE: Installed Brackets can be used for additional ganging (FIGURE C)






NOTE: Brackets are pre-installed on one side

Two Screws and Nuts per Bracket





#### MOUNTING SINGLE CABLE DUCT BETWEEN 2 OR 4 POST RACKS


Using supplied hardware, install Brackets as shown (four places). See **FIGURE B** for appropriate orientation.

# **HINGE CLIP AND COVER INSTALLATION**

The 'HINGE CLIP' connects the COVER to DUCTS, allowing the Cover to swing open and closed for optimum cable management.



1) Slide the 'hook portion' of the Hinge Clip onto the Cover as shown. (FIGURE A)





## RECOMMENDED: Space two (2) Hinge Clips three (3) inches from the cover edges, and one additional clip in the center portion of the cover as shown. (FIGURE B)



## 2) Once the clips are attached to the cover, align each clip beside and in-between two fingers. (FIGURE C)
