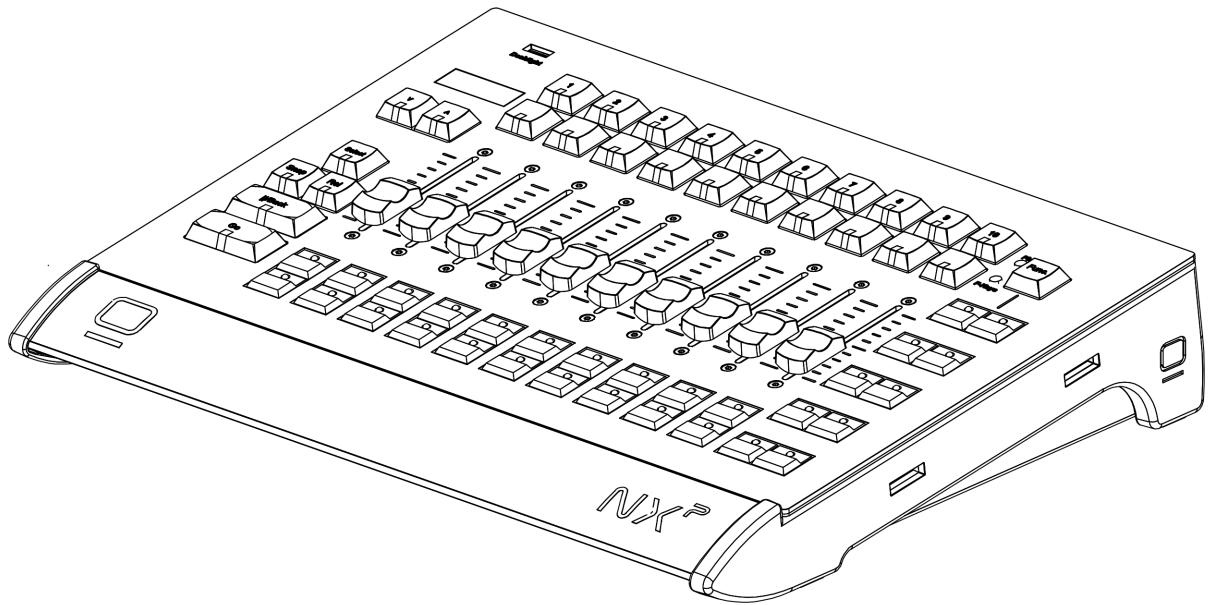

OVERVIEW

The **NX P** is a motorized fader wing for **ONYX**. The ideal expansion for the NX1 console and ONYX PC systems, it replicates the full playback section of the NX1 console. Four integrated DMX ports provide instant connectivity to the lighting system.

Multiple NX P wings can be connected to any ONYX console or PC system, expanding direct access with 20 playbacks at a time. The flexible button array can be mapped to playback control or powerful function keys. The NX P replicates the layout and all functionality of the NX1 and NX4 console surfaces so all operation is seamless and intuitive.

A simple magnetic alignment system allows attachment on any side of the NX1 Console, or NX K Command Pad. The keypad and playback wing are part of the ONYX platform and can be utilized with all other NX devices or ONYX on any PC system.

PC SYSTEM REQUIREMENTS FOR NX P

Onyx is designed to be operated on PC systems that utilizes a multi-touch touch screen.

Without the touchscreen the system will provide a poor user experience and may be difficult to use.

The PC should meet these minimum recommendations; higher universe counts may require more powerful systems:

- Windows 10
- Intel Core i3 processor 6th Generation+
- 4 GB RAM
- 2 GB available disk space (SSD recommended)
- Widescreen monitor, minimum 1280 wide, 768 high (capacitive multi-touchscreen recommended)
- USB 2.0 port
- 10/100 Ethernet port for Art-Net DMX output
- 100/1000 Ethernet port for X-Net, remote operation and sACN

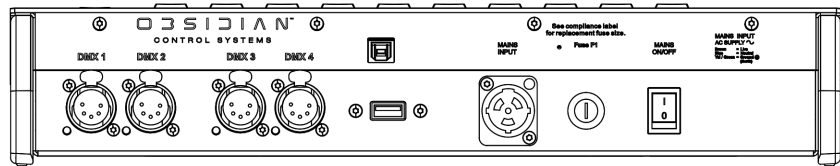
The Obsidian Control Systems NX P accepts AC mains power at 100-240V 50/60Hz. Do not connect it to power outside this range. Damage resulting from incorrect connection is not covered under warranty.

North America: A cable with a NEMA 15-5P plug is provided for use with the NX P in the USA and Canada. This approved cable must be used in North America.

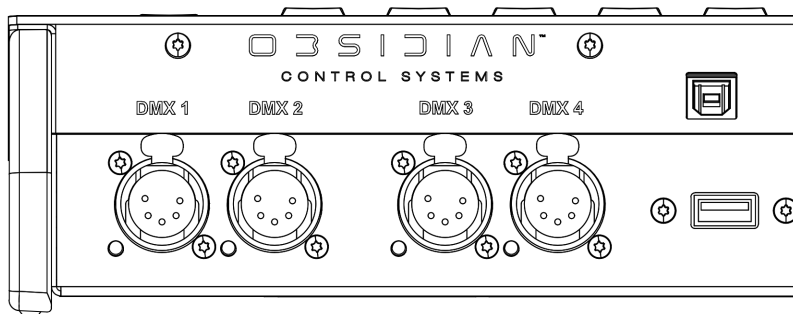
Rest of the world: The provided IEC cable is not fitted with a country-specific plug. Install only a plug that meets local and or national electrical codes and is suitable for the country's specific requirements.

A 3-prong grounded-type (earthed type) plug must be installed following the plug manufacturer's instructions. The table below shows some possible pin identification schemes; if the pins are not clearly identified, or if you have any doubts about proper installation, consult a qualified electrician.

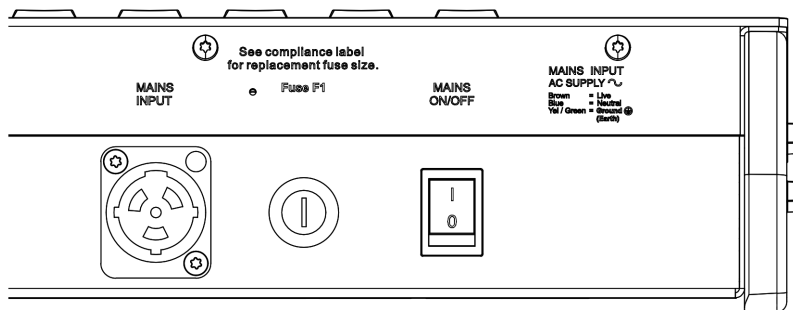

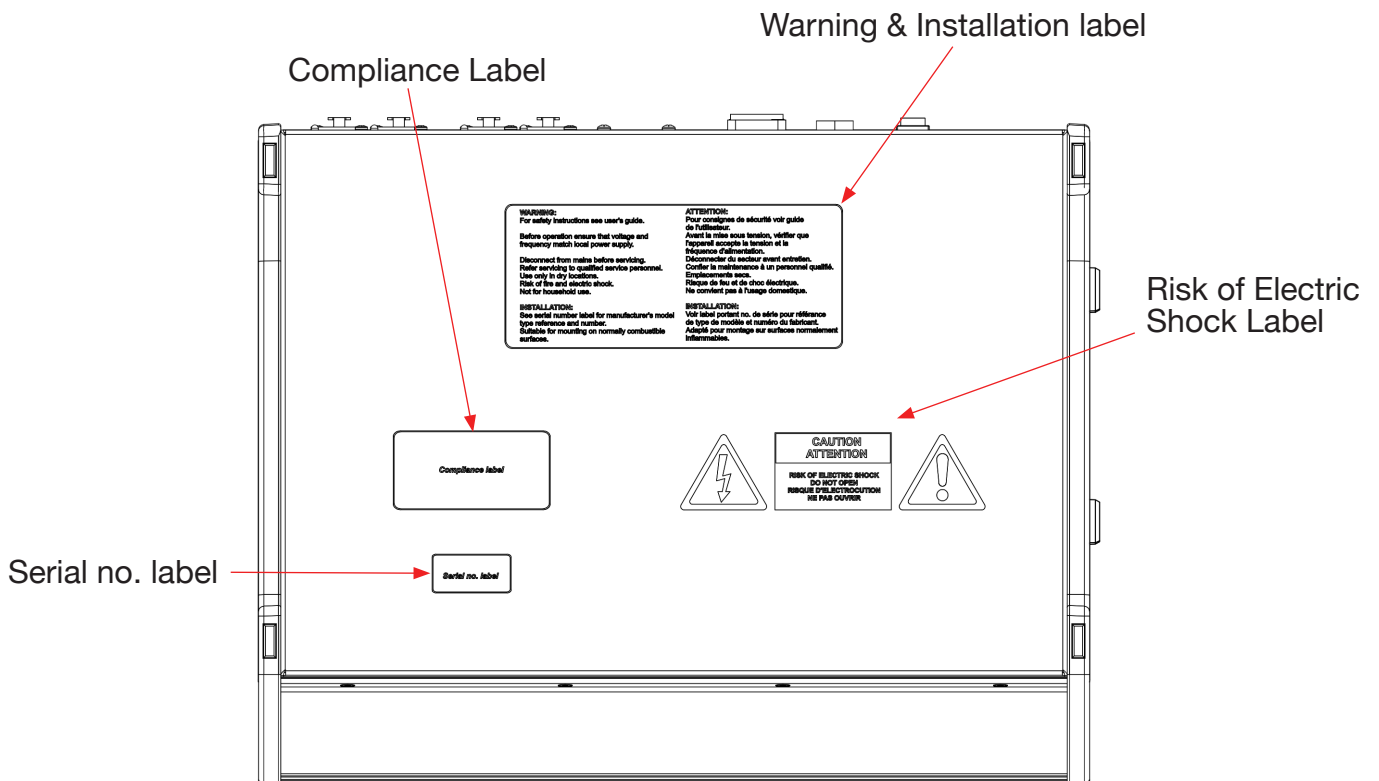
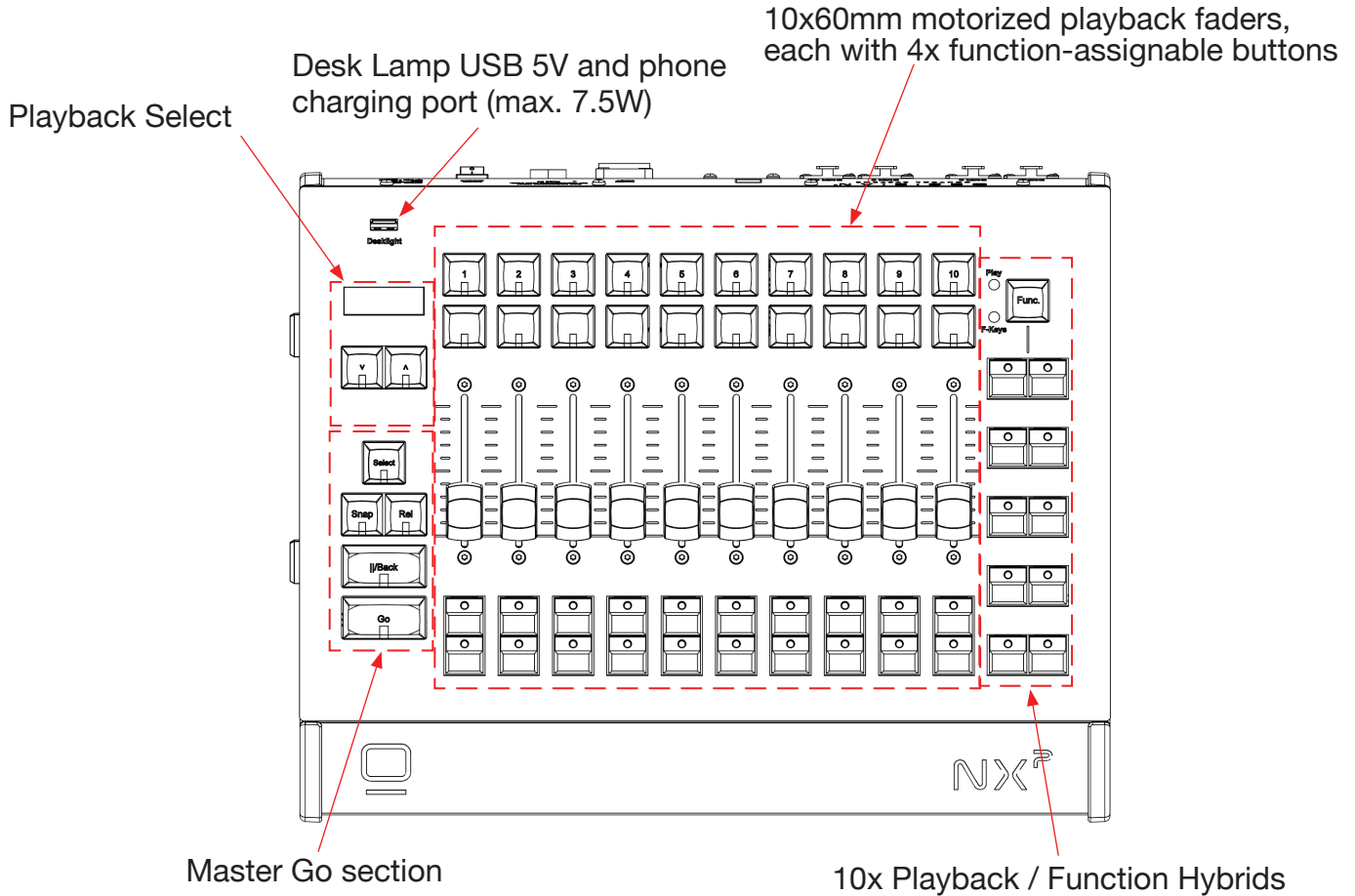

MAINTENANCE

The Obsidian Control Systems NX P is designed as a rugged, roadworthy device. The only required service is occasional cleaning. For other service-related concerns, please contact your Obsidian Control Systems dealer, or visit www.obsidiancontrol.com.

Any service that is not described in this guide must be carried out by a trained and qualified Obsidian Control Systems technician.

As any computer, the NX P requires periodic cleaning. The schedule relies on the environment in which the controller is operated. An Obsidian Control Systems technician can provide recommendations if necessary.

Never spray cleaner directly onto the device surface; always spray into a lint-free cloth and wipe it clean. Consider using cleaning products designed for cellphone and tablet devices.



Important! Excessive dust, dirt, smoke, fluid build-up, and other materials can degrade the performance of the NX P device, causing overheating and damage to the unit that is not covered by the warranty.
